**BOSS OF THE YEAR—
ERNEST L. GREER, ESQ.**

**WHY MY BOSS SHOULD BE BOSS OF
THE YEAR**

My boss is a person some people underestimate because of his friendly, fun-loving personality. At only 39 years old, he has accomplished what many attorneys his senior are still working to achieve. He is the youngest shareholder at our Firm's Atlanta office, is the co-chair of the Atlanta Litigation Department and is a member of the Executive Committee for the entire Firm (we have 33 offices throughout U.S. and Europe). Most recently he was chosen by the American Diabetes Association as Father of the Year 2006. His professional and community involvement include: General Counsel of the National Association of Minority Contractors (Atlanta); Member of the Board of Directors of the Atlanta Legal Diversity Consortium, Inc.; Member of the Board of Directors of the Fulton County Arts Council; Member of Leadership Atlanta, Class of 2004; Member of the 100 Black Men of Atlanta, Inc.; President-Elect, Trinity School Parents Association; and Member of the Atlanta Bar Association's Committee for Judicial Selection and Tenure.

He was also selected as one of "Georgia's 2005 Super Lawyers Rising Star" by *Atlanta Magazine* and *Georgia Super Lawyers* and has been featured and quoted in many other magazines, news articles and periodicals. Of course, behind every great man is a great woman, and in his case there are three – his wife and two daughters (who are his biggest fans)! He is ever mindful of the life lessons taught him by his parents and to honor them he recently established an Enrichment Fund at his preparatory school, named for his mother and late father, for the purpose of providing monies to students to cover the expenses of extracurricular activities and other opportunities not covered by their tuition. Yes, my boss has accomplished much over the past few years, but that is not why he should be Boss of the Year.

He should be Boss of the Year because he encourages our team to be the best they can be for our clients. He asks for one hundred percent, yet, he

gives one hundred and ten percent because he will never ask us to do anything he won't. He is one of the few shareholders at our Firm to whom employees feel comfortable to approach for help on both legal and personal issues, despite the fact that many of these employees do not know him well or even work in our department! He is well-known in our office for his ability as a deal-maker; providing solutions to seemingly impossible situations and providing a good result for each party. He is the "Go To Guy" for many attorneys in our Firm for his advice and insight. (I often tease that I need to install a "Take a Number" system on his door similar to those at the deli counter). He is also well-known and respected within the legal community by his peers and the judiciary.

He should be Boss of the Year because he shows kindness in unexpected ways. He is the ONLY boss I have ever had who asks me whether I have received my raise yet and if it was satisfactory and reminds me not to forget to write down my overtime. He has always been supportive of my membership in NALS and has demonstrated his support over the years, assisting in any way he could, whether by assisting me financially, or by allowing the use of the Firm facilities to hold a certification study group, and the PLS exam. Even when he is out of the office, he looks out for his team members. When a newly-hired attorney who had just moved to Atlanta became ill, my boss asked two other employees to leave work immediately and go to the hospital to stay with the attorney until we were assured all would be well and then he ensured that the attorney had access to food and a support system when discharged from the hospital. Occasionally, when employees for the building in which our office is located encounter legal problems, my boss generously provides legal services pro bono, never boasting about these acts of generosity to anyone. Often I am unaware of the situation until the person shows up for an appointment or approaches me in the lobby to say how much they appreciate his kindness. My Boss should be Boss of the Year because he treats our employees with genuine respect and engages in an easy camaraderie with everyone from the cleaning staff to management, displaying a warm and friendly attitude for which he is greatly admired. My boss knows that family comes first and he never loses track of the reason we come to work in the first place. In all the years I have worked with him, no matter what legal battles were raging in his office at

the time, I know I can ALWAYS transfer a telephone call from one of his children to him and even while he is in the midst of a heated discussion, he will proudly tell his audience, "excuse me, but this is my daughter on the phone" - putting his guests, and the legal battle at hand, into proper perspective.
